WHEREAS, the Soulchestra holds significant expertise in Music & Entertainment and offers services in Music Production & Artist Development for which the Partner would like to engage according to the terms and conditions herein.

NOW, THEREFORE, In consideration of the mutual covenants and promises made by the parties within this Contract, the Soulchestra and the Partner (individually, each a “Party” and collectively, the “Parties”) covenant and agree as follows:

1. EVENTS

The Partner shall allow / participate in the event in [SUBJECT MATTER] in accordance with the schedule attached hereto as Exhibit A.

2. PAYMENT

4. PUBLICITY AND MARKETING

The Soulchestra authorises the Partner to utilise the Soulchestra's logo and associated trademarks as well as any media, photos, or footage from any events solely for the purpose of marketing the Partner's services.

5. NO MODIFICATION UNLESS IN WRITING

No modification of this Contract shall be valid unless in writing and agreed upon by both Parties.

6. APPLICABLE LAW

This Contract and the interpretation of its terms shall be governed by and construed in accordance with the laws of the State of Michigan and subject to the exclusive jurisdiction of the federal and state courts located in Wayne County, Michigan.
